## TERMS AND CONDITIONS FOR USE OF [WWW.THESTOCKSONAR.COM](http://WWW.THESTOCKSONAR.COM)

PLEASE READ CAREFULLY THE FOLLOWING TERMS AND CONDITIONS OF USE ("TERMS OF USE") BEFORE ACCESSING OR USING THE SERVICE. **IF YOU DO NOT FULLY AGREE WITH THE TERMS OF USE, YOU MUST REFRAIN FROM REGISTERING FOR AND/OR USING THE DIGITAL TROWEL SERVICE AS THESE TERMS AND CONDITIONS OF USE CONTROL.**

These Terms of Use constitute a legal agreement between You (or "Customer") and Digital Trowel, Inc. ("Digital Trowel", "We" or "Us").

You agree that these Terms of Use will govern your use of and subscription to [www.thestocksonar.com](http://www.thestocksonar.com) (the "Digital Trowel Service"). Renewal of your subscription shall also be governed by these Terms of Use. The instant license to use the Digital Trowel Service is provided to You by Digital Trowel, Inc., Park 80 West Plaza One 250 Pehle Avenue - Suite 211 Saddle Brook, New Jersey 07663. By subscribing and/or using the Digital Trowel Service, YOU SIGNIFY YOUR AGREEMENT TO AND AUTHORITY TO BE LEGALLY BOUND BY THESE TERMS OF USE AND TO THE PRIVACY POLICY IN EFFECT FOR DIGITAL TROWEL. Digital Trowel reserves the right to update and change these Terms of Use from time to time without notice or acceptance by You. Such changes, modifications, additions or deletions shall be effective immediately upon notice thereof, which may be given by means including, but not limited to, posting on [www.thestocksonar.com](http://www.thestocksonar.com). Any use of the Digital Trowel Service after such notice shall be deemed to constitute acceptance by You of such changes, modifications, or additions.

1. **License.** Digital Trowel grants to Customer a non-exclusive, non-transferable, limited right to access and use the Digital Trowel Service in accordance with these Terms of Use. Customer is solely responsible for selecting, purchasing, installing and maintaining the hardware, equipment, and software necessary to use the Digital Trowel Service.
2. **Termination.**
  - o Digital Trowel may immediately terminate your access and usage rights, and supply notice thereof, if Digital Trowel reasonably believes that the Customer has engaged in activity that violates applicable law or any provision of these Terms of Use.
  - o All obligations under these Terms of Use after Customer's access and usage rights terminate shall survive such termination with respect to any events that occurred prior to the effective date of any termination.
3. **Copyright and Trademarks.** The Digital Trowel Service contains proprietary content of Digital Trowel that is protected by copyright and other laws respecting proprietary rights, including, but not limited to text, software, photos, video graphics, databases, icons, hyperlinks, designs, and pricing information. 11. Assignment. This license will be binding upon the parties and their respective successors and assigns. No Customer may assign any of its rights or delegate any of its obligations under this license granted herein without the prior written consent of Digital Trowel.
12. Miscellaneous. These Terms of Use do not create any joint venture, partnership, agency or fiduciary relationship between the parties. These Terms of Use represent the entire agreement of the parties and supersede all other oral or written understandings regarding the subject matter hereof. If any provision is held by a court of competent jurisdiction to be contrary to law, such provision shall be limited or eliminated to the minimum extent necessary so that these Terms of Use shall otherwise remain in full force and effect. Each party shall be responsible for compliance with all applicable laws, rules and regulations, if any, related to the performance of its obligations under these Terms of Use. Neither party will be liable for any failure to perform any obligation (other than payment obligations) hereunder, or from any delay in the performance thereof, due to causes beyond its reasonable control.
